- Operate CMM machines and maintain CMM work instructions for the set-up and inspection of parts.
- Perform all programming of the CMM machines using ZEISS software from Model Based Definition and 2D drawing.
- Analyze and interpret blueprints, models, evaluation sheets, manuals and other materials to determine specifications, inspection and testing procedures, adjustment and certification methods.
- Collect and analyze inspection data and make computations as necessary to determine inspection results and perform first article inspections.
- Communicate information to others about inspection results, part status, updates, specific instructions, etc. and participate in PFMEA activities.
- Determines product suitability for shipment for company and customer
- Work closely with Engineering on related issues, including MSA, Gage R-N-R, and statistical studies
- Plan and work as a key member of the production team to ensure high quality product and on time delivery.
- Provide support for Lean manufacturing and continuous improvement initiatives, companywide.
